PARAT® C: Exposure Time against H₂S

The exposure time of PARAT® C against H₂S has been officially tested from the independent laboratory BGIA.

Following exposure time of PARAT® C against hydrogen sulphide (H₂S) was confirmed under given conditions:

Exposure time: 120 minutes (which are in conjunction to the DIN 58647-7 standard):

- 1) Measured with a concentration of 2500ppm H₂S
- 2) Under a constant flow of 30 Liters per Minute

Please keep in mind that the exposure time is dependent upon the measured concentration of the H₂S. If higher concentrations of H₂S are present, this will shorten the exposure time.
